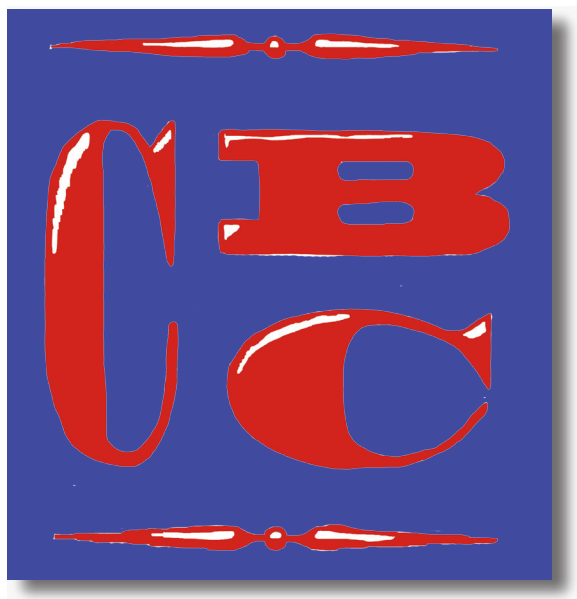

As an applicant, you may be tested using video judging, rulebook testing and an interview session. Your personal presentation will also be evaluated throughout the seminar. Associations may provide their applicants with their overall score, however, CBC, Inc. will not be responsible for the release of testing scores.

Applicants are required to wear appropriate judging attire applicable for the breed you are applying with during all applicant sessions, unless the schedule or the association(s) you are applying with indicates otherwise. During video sessions, no hats will be allowed.

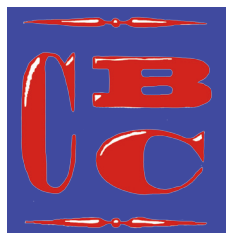
